## **Rules and regulations of the grant competition for migrant projects “RefugeeFund”**

### **§ 1 GENERAL PROVISIONS**

1. Fundacja Konflikt carries out the grant competition by awarding grants of 3,000 and 5,000 PLN to individuals or groups of people.
2. The competition is organised by Fundacja Konflikt with the KRS number 0000635116. The project is implemented in cooperation with HIAS.
3. The organiser of the competition is responsible for conducting the competition properly.
4. The aim of the competition is to support projects started by or with people with migrant and refugee experience in Poland.

### **§ 2 PARTICIPANTS**

1. The projects can be carried out by individuals or formal/informal groups.
2. The projects can be submitted by people with migrant and refugee experience, who currently reside in Poland.

### **§ 3 RULES AND CODE OF CONDUCTS**

1. We will finance 18 projects. Ten of them will receive 3,000 PLN, and the other eight will get 5,000 PLN. We will discuss the schedule for funding with each winner individually. The funds will be transferred to the winners based on a signed agreement.
2. Types of projects we finance:
  - social and civic projects
  - educational, cultural and artistic projects
  - projects which strengthen, activate and network your community
  - self-advocating projects carried out in defence of the rights and interests of people from your community

4. Applications are accepted from 01.05 to 16.05.2023 (until 23:59)
5. Formal criteria:
  - the application form is completed correctly and contains all the necessary information
  - the application form is sent in due time
6. The organiser of the competition will appoint a four-person jury, which will choose the winners.
7. The projects will be assessed on the basis of their social impact, innovativeness, and whether they are realistic to implement.
8. The jury will choose 18 projects until May 24th, 2023.
9. The organiser will announce the winners on this website: [LINK](#) and on social media: [LINK](#)
10. The organiser will only contact the winning projects.
11. The projects must be implemented between 01.06-30.09.2023.
12. Each winner must prepare photographic evidence of the project, which will be used on the website and social media of Fundacja Konflikt. By taking part in the project, you consent to the publication of your photos.

#### **§ 4 FINAL PROVISIONS**

1. The organiser reserves the right to change the competition schedule during the duration of the project.
2. The organiser of the competition reserves the right to unilaterally change these Rules and regulations.
3. In the matters which are not regulated by these Rules and regulations, the decision will be made by the organiser.
4. The organiser reserves the subjective right to reject projects which are discriminatory or violate human rights, and those that are unoriginal and not independent.
5. Along with submitting the form, the applicant confirms that their work is the result of their creativity and that they are entitled to copyrights of the work.
6. The organiser shall not be liable for any infringement of copyrights of third parties, and the participant is obliged to cover the damages resulting therefrom. The organiser is not held accountable for any damage caused by providing false information or other types of irregularities on the part of the applicant.
